## SHOULD YOU WORRY ABOUT INDUSTRIAL ESPIONAGE AND CYBER CRIME?

- The Cyber Crime threat for today's business ~ nobody is safe
- 70% of Cyber Attacks/Incidents are internal (that means they were on the inside of a firewall) (FBI/CSI)
- Florida is the 2<sup>nd</sup> highest ranking state for Computer Crime (FBI-2002)
- Reported Cyber Attacks went from 3,734 in 1998 to 82,094 in 2002 (Carnegie Mellon CERT)
- 90% of Cyber Attacks could have been avoided by known methods (Gartner Group)
- Identity theft has increased by 35% in the past two years (Carnegie Mellon CERT)
- Theft of trade secrets has increased by 100% (to \$6.6 million) annually in the past 2 years (CSI survey)
- The key element in protecting yourself ~ the one who holds the keys
- One cyber attack can put you out of business
